2. The progress of this time

GEM (Wuxi) and Wuxi Airport Economic Development Zone and Wuxi New District Science and Technology Finance Venture Capital Group Co., Ltd. based on the principle of reciprocity, signed a capital cooperation contract for GEM Power Battery Low-Carbon Cycle Project, Wuxi Airport Economic Development Zone, Wuxi New District Technology Finance Venture Capital Investment Group Co., Ltd. will participate in the capital investment of the company's Wuxi power battery recycling project, and the specific investment amount and equity ratio will be separately agreed. All parties will use their respective advantages and strengths to jointly build the company's Wuxi New Energy Circular Economy Low-Carbon Demonstration Park, and build a "power battery recycling - new energy vehicle recycling - power battery

cascade utilization - auto parts cascade utilization - new energy material remanufacturing. "The new energy full life cycle low-carbon industrial model, to promote new energy vehicles from "green to green".
